## National EMSC Related Updates (Hendry and Jean-Jacques)

1. NEDARC EMSC 2022 EMS Agency Survey is in progress, closes March 31, 2022 with a focus on performance measures 2 and 3 (PECC and pediatric equipment). For example, does your agency have a PECC or some type of pediatric coordination plan, how do you teach the use of pediatric equipment, etc. It is important to have the most qualified person in the agency complete the questions. HRSA would like to see an 80% completion rate.

2. The 2021 NPRP Assessment (ED pediatric readiness) survey is complete with some preliminary data available: FL had a 58% response rate. New ACS standards will include the pediatric readiness survey for trauma centers. It is not recommended to compare to 2013 NPRP results as many questions have changed. The numbers are down for PM 06 and 07 but scoring of impact factors may have changed. Dr. Hendry will discuss with NEDARC.


8. Pediatric Pad Defibrillator Compatibility and material shortages

Dr. Hendry reviewed correspondence from the NASEMSO PEC regarding pediatric defibrillator supply shortages. The Lifepak 12 Manual states it is not intended for less than 8 yrs of age. Due to order backlogs of pediatric pads, there is an updated letter from the manufacturer stating using the device will not harm the patient if under 8 yrs of age. All agencies and EDs are asked to review their pediatric supplies as there are numerous national equipment shortages.

### Florida EMSC/PEDReady Updates

1. The PEDReady website was updated with meeting materials, disaster badge buddies, new ED and EMS checklists: https://emlrc.org/flpedready/.

The annual EMSC map was updated in November 2021. Florida continues to have rapid growth of EDs with over 300 ED's, a large increase of Free-standing EDs, and 303 EMS Agencies. Federal funding is not representative of population.



2. Transport of minors and documentation of parental consent in the ED: Parents' Bill of Rights https://www.myfloridahouse.gov/Sections/Bills/billsdetail.aspx?BillId=70313.

Details regarding this legislation and upcoming revisions where discussed. Very strict language about documentation of consent and who can provide emergency care. See slides for details. Very important at EMS to ED handoff to discuss who gave consent and obtain guardian contact information. In ED setting, attending physician must document details if written consent not obtained.

- 3. Target Zero Initiative (FDOT) to reduce number of transportation-related injuries and deaths across Florida to ZERO. Focuses on identifying behaviors that contribute to crashes, understanding who makes up the target audience, and creating impactful messages to influence specific behaviors. <a href="TargetzeroFL.com">TargetzeroFL.com</a>
  David Summers offered to be a participant and provide updates
- 4. Button Battery ingestion prevention campaign and legislation Dr. Hendry contacted to ask for EMSC support in Button Battery ingestion prevention campaign and legislation in collaboration with consumer protection agency. There have been several high-profile cases in Florida with poor outcomes. There is a limited treatment window to prevent injury to the esophagus and/or airway and a very high-risk scenario compared to swallowing a coin. Often the ingestion is unknown. EDs and EMS agencies are recommended to have protocols for button (disc) battery ingestions.
  - Dr. Antevy parents not aware of immediate issue and just call for EMS services. Giving honey can neutralize some of the acid and has been added into protocols in some areas.

  - Wendy Devanney with Ascension working on a Button Ready Campaign, in the early stages
  - Lisa Nichols with Baptist/WCH added button battery ingestions confirmed by Xray as a Trauma Activation to elevate treatment.
  - Protocols are especially needed in free standing EDs and rural settings.
- 5. Monique Burr Foundation Child Safety Matters Program: offers prevention programs for four types of child abuse (physical, emotional, sexual, and neglect), exploitation, bullying, cyberbullying, human trafficking, digital abuse, and other digital dangers. <a href="https://www.mbfpreventioneducation.org/resources/">https://www.mbfpreventioneducation.org/resources/</a>

Dr. Hendry will coordinate a future presentation. Program free to Florida schools.

- 6. Children with Special Healthcare Needs STAR questions (presented by Advent Health Robin Ritola / Chantelle Bennet Child Life Specialist)
  - **STAR stands for S**ensory, **T**actile, **A**uditory, **R**ockstar. See question in presentation slides. The group discussed how to adapt for EMS and share with other EDs and agencies. STAR includes safety concerns- behaviors to be aware of, how does the patient communicate best, what procedures or health care experiences may be upsetting to patient, and what are the best ways to calm the patient? This resource is great for autism patients (1 in 44 US children have an autism spectrum disorder).
    - Lauren Young; Consider use with other children with mental health issues (PTSD, Sensory, etc.)
    - The group determined the need to continue the discussion and PEDReady will help develop materials for statewide dissemination
    - Working group to include Robin, Chantelle, Sandy N, Lauren, Dr. Hendry, and others TBD.
- 7. CARES/BioSpacial update and FL Resuscitation Academy with pediatric components (PEDReady sponsorship)
  - a. Dr. Hendry will work with Tom DiBernardo and Ty Carhart to develop a Pediatric Dashboard with intubations, arrests, etc.
