Although many of these are minor ingestions, there are at least seven different classes of substances that can lead to severe toxicity or even death with even small ingestions in children.

- Identify the list/classes of medications that can be harmful in only small amounts (1-2pills) if ingested.
- Describe the steps to quickly initiate therapeutic and life-saving interventions.
